EA RENEWAL

The 2015 Enrollment Renewal Application Period is open from November 1, 2014 through January 31, 2015. Per U.S. Treasury Department Circular No. 230 (Rev. 6-2014), you are required to renew your EA status during this time frame if your SSN ends in 7, 8, 9; or you do not have a SSN. Without renewal your current enrollment will expire on March 31, 2015.

Do you check your continuing education credits on a consistent basis? Sign in to your PTIN account and access your CE credits. For renewals, these CE credits will be automatically checked against your renewal application.
